### **BOARDER RESPONSIBILITY & PRIVILEGES:**

### **AMENITIES**

- Use of lighted outdoor riding arena and pastures.
- Use of washing facilities and tack room
- Use of stadium jump course as determined by trainer
- Outdoor stalls with windbreak

### **SHOOTING STAR HORSES RESPONSIBILITIES**

1. Board consists of pasture access in accordance with how well horses integrate into the herd. .
2. The boarded horse will be fed grain up to 1 to 2 times per day (depending on health and use of the horse), 7 days per week. The manager, trainer and boarder will determine the grain amount. Supplements will be fed if purchased by boarder and should be provided in SmartPaks if available.
4. The boarded horse will receive free access to hay and pasture. Hay type included in normal board cost could be prairie, blue grass, Bermuda and/or brome. SSH produces its own hay and uses what is available for the season.

5. The boarded horse will receive as much turnout as possible. We offer group pasture turnout only. Your horse will be introduced into the pasture through a smaller adjoining pen.

6. The manager will make appointments and notify all boarders when the farrier and the vet are coming. All horses must stay current on vaccinations and coggins.

## **LIABILITY**

1. By signing below Boarder agrees to hold harmless **SHOOTING STAR HORSES** and **ASSUMES ALL RISK** associated with horseback riding and related activities including but not limited to leading, grooming, feeding, horse shows, etc...

2. By signing below, Boarder is aware of the dangers involved to people and horses including but not limited to: death, paralysis, whiplash, bodily injury, falls, kicks, bites, collisions with vehicles, collisions with horses or stationary objects, fire, explosions, the unavailability of on property medical care, or the negligence or deliberate act of another person.

3. By signing below Boarder agrees **NOT TO SUE** or hold liable **SHOOTING STAR HORSES**, the managers and all of its successors assigns, subsidiaries, franchise affiliates, officers, directors, employees, agents, owners of other horses on premises and agrees to completely hold them all harmless.

4. By signing below Boarder has viewed the Ranch, its' fencing, pastures and facility and has deemed them "safe" to place the above described horse on the premise and at that point assumes the risk and expense of said horse becoming injured in any way while on the premise.

5. By signing below Boarder acknowledges that **SHOOTING STAR HORSES** does NOT carry "Care, Custody and Control" Insurance.
